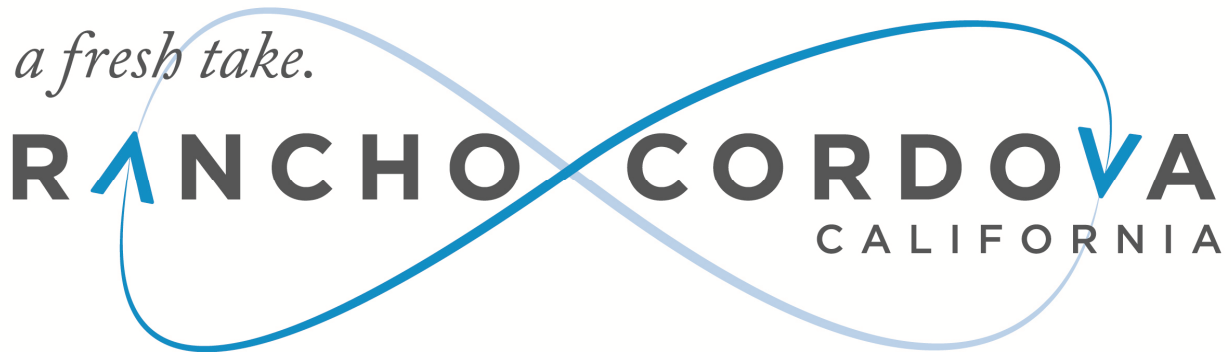

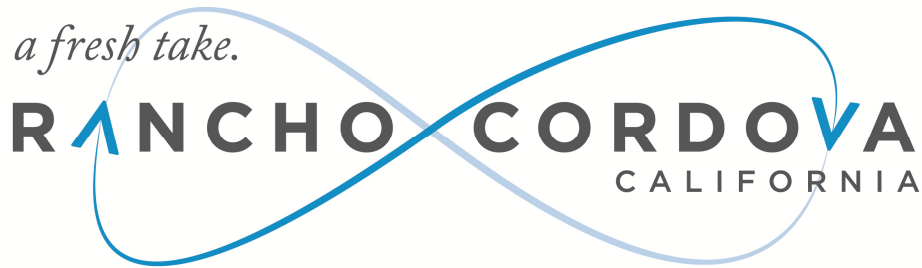

On June 2, 2014, the City Council approved resolutions ordering the preparation of the Engineer's Annual Levy Report, and set the public hearing to be held prior to approving and ordering the levy of assessments for Fiscal Year 2014-2015. The assessments fund the ongoing maintenance, servicing and operation of public lighting improvements (safety lights and street lights) in the District. There are no new impacts to existing or new residents. No assessments shall increase as a result of this action.

- 11.1 **Subject:** Resolution Establishing November 4, 2014 as the Date for an Election on a Proposed Ballot Measure Seeking Voter Approval to Impose a One-Half of a Cent Transactions and Use ("Sales") Tax for General City Services, Establishing Policies and Procedures in Connection with Such an Election, and Requesting that the County of Sacramento Conduct such an Election.

Recommendation: Staff recommends adoption of Resolution No. 98-2014.

Result of Recommended Action:

If the City Council adopts the Resolution, residents of the City of Rancho Cordova will be provided with the opportunity to vote on a ballot measure in the November 4, 2014 General Election. If approved by the voters, the ballot measure would enact a one-half cent sales tax to enhance City services, facilities and programs, including:

- Enhancing anti-gang and youth violence prevention programs
- Increasing neighborhood police patrols
- Fixing streets faster
- Expanding children/teen after-school programs
- Removing blight/revitalizing vacant buildings along Folsom Boulevard
- Building recreation facilities for seniors, working adults and children
- Other general city services.

The City Council's action does not connote support or opposition to this measure, but simply places it on the consolidated ballot for local voters to decide.

- 11.2 **Subject:** Ordinance No. 20-2014, Amending Title 8, "Animals," of the Rancho Cordova Municipal Code Regarding the Definitions and Procedures Pertaining to Potentially Dangerous and Vicious Animals, Administrative Citation Appeals, Barking Dogs, and the Authority of Animal Services Officers to Use Weapons.

Recommendation: Introduce and waive the first reading of Ordinance No. 20-2014.

Result of Recommended Action: Adoption of this Ordinance will clarify the definitions and procedures in the Municipal Code related to potentially dangerous animals, barking dogs, and administrative citation appeals; it will also amend the Municipal Code to give trained animal service officers the authority to use a firearm in limited circumstances where an injured or sick wild animal is causing an immediate threat to public safety. If the Ordinance passes first reading tonight it will return for a final reading and adoption at the next regular City Council meeting.

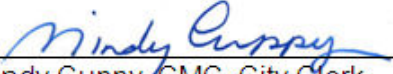
